WEDNESDAY, JANUARY 18, 2023 – 7:00PM**

1. **Call meeting to order** – *Called to Order by Chairman Gehrke at 7:00PM. Village President Dohrwardt and Trustee Paape in attendance.*
2. **Approve minutes from the November 30, 2022, Parks and Recreation Committee meeting** – *Motion to Approve by Dohrwardt, 2nd by Paape. Approved Unanimously.*
3. **Movie: NOSD** – *Movie night set for February 9th at 7PM at the Commons area at Northern Ozaukee School District Campus showing “Clifford”. Tap into school groups to for concessions.*
4. **Mud Run Brainstorm** – *Administrator Jenkins introduced the idea of a Summer Youth Mud Run event. Stressed need for planning and volunteers. Committee will invite West Bend Parks & Rec Director Mike Jentsch to next meeting to share details of setup for an event like this.*
5. **Disc Golf Course Maintenance** – *Chairman Gehrke discussed installed QR codes to collect donations along the course and explained ability to obtain donated wood to rebuild bridges along the course.*
6. **Fire Department 100th Anniversary Event** – *Letters went out for participants to be involved in the celebration. Emphasized need for volunteers and marketing for event. Administrator Jenkins discussed that public safety items are covered between Village Departments and help across Ozaukee County.*
7. **2023 Summer Park Program** – *Chairman Gehrke discussed whether to continue Summer Park program for youth or not. Port Washington’s program will run for 8 weeks starting the week of June 19th. Administrator Jenkins shared possible collaboration with NOZSD. Committee agreed to explore options.*
