Call to order on public hearing that the Village Board of the Village of Fredonia, Wisconsin has declared its intention to exercise its police power in accordance with Wis. Stat. 66.0703, and Chapter 60 of the Village Code, to levy special assessment upon property within the following described assessment district for benefits conferred upon the property by the repair or replacement of sanitary laterals:

Strohm presented information to Edmaro Street residents explaining the problem of inflow and infiltration and the village's rationale behind replacing clay and cast iron pipes with PVC when Edmaro Street will be reconstructed this year. Several residents expressed frustration with the necessity of having this done when laterals on other streets such as Fredonia Avenue were not needed to be replaced a few years ago. There were questions about a few properties on Edmaro Street that were not included on the list for sewer lateral replacement. There were questions about the need to replace laterals if current ones were not televised, and may not be leaking. Dohrwardt explained future road projects will include replacing sewer laterals with PVC if pipes are clay or cast iron. I&I creates a lot of treating of groundwater at the wastewater treatment plant where it should be reduced instead. After hearing concerns of all citizens in attendance, the public hearing was closed.

The regular village board meeting was called to order at 8:00 p.m. by President Donald Dohrwardt. Report on Operations of Village by Village Marshal

The report from the Village Marshal was reviewed.

HIRE DEPUTY MARSHAL: Davel stated that Officer Podewils' last day is May 10th and would like to start the process started of hiring a replacement that will be able to fill the vacancy. After discussion, a **MOTION** to allow the village marshal to start process of hiring a deputy marshal by Haas, seconded by Abegglen, and carried. Davel stated that he will not be at the next village board meeting.

Report on Operations of Village by Director of Public Works

The report from the Director of Public Works was reviewed. Strohm stated the crew repaired a water main break that occurred by the high school today. An ad was sent to the Ozaukee Press for summer help to publish next week. Approval of summer help will be placed on the next village board agenda. Dohrwardt stated that he would like to see some flexibility to start summer help early if needed.

Report on Operations of Village by Wastewater Treatment Plant Operator

The report from the Wastewater Treatment Plant Operator was reviewed.

Report on Operations of Village by Clerk-Treasurer

The report from the Clerk-Treasurer was reviewed. 530 ballots were cast at the April 2, 2019 election -38.46% voter turnout. Board of Review will be held May 16, 2019 from 6:00 p.m. -8:00 p.m. A quorum will be needed.

Plan Commission – March 25, 2109 meeting

The minutes from the Plan Commission – March 25, 2019 meeting were reviewed.

ORDINANCE 2019-03 AMENDING VILLAGE OF FREDONIA CODE OF ORDINANCES PERTAINING TO NUMBER OF ALLOWED ACCESSORY STRUCTURES WITHIN THE VILLAGE: The Plan Commission recommends amending Section 200-3(C)(5)(3)(a-c) of the Village of Fredonia Code of Ordinances permitting one attached garage, one detached garage and one shed and replacing with *One detached garage and one shed are permitted on any residential lot. More than two detached accessory structures require approval by the Plan Commission.* After discussion, a **MOTION** to adopt Ordinance 2019-03 Amending Section 200-3 Amending Village of Fredonia Code of Ordinances Pertaining to Number of Allowed Accessory Structures Within the Village by Long, seconded by Bertram, and carried.

REQUEST RFP FOR INDUSTRIAL PARK PROPOSAL: Dohrwardt stated the Plan Commission recommends the village move forward with an industrial park. A representative from MLG met with office staff, and they would like to work with the village. After discussion, a **MOTION** to proceed with request for industrial park proposal by Haas, seconded by Long, and carried.

Economic Development Committee – March 25, 2019 meeting

The minutes from the Economic Development Committee – March 25, 2019 meeting were reviewed. Meyers-Jansky submitted a report of accomplishments of the committee.

NARROW BRANDING LINE: The committee has been working on a branding statement and has seven choices and wanted the village board's opinion to narrow down

the selections. After a series of votes, the choices were: "Live, Work, Play", "Life Made Simple" and "Find Your Moments Here".

Parks Committee – April 4, 2019 meeting

Bertram stated there will hopefully be a recommendation for work at the new park at the next village board meeting. The Parks Committee narrowed down names for the park to Endeavor or Freedom. The new slide structure will be installed at Stoney Creek Park this summer.
