<u>Presentation by Wendi Unger, Baker Tilly US LLP, on the Village of Fredonia</u> <u>Financial Statements for the Year Ended December 31, 2020</u>

Wendi Unger, partner with Baker Tilly US LLP, presented the Village of Fredonia Financial Statements for the Year Ended December 31, 2020. She spoke about highlights from the audit including an unmodified audit opinion has been issued on the financial statements, that the financial statements are fairly presented in accordance with generally accepted accounting principles, and all appropriate disclosures have been properly reflected in the financial statements. Material weaknesses include internal control environment and internal controls over financial reporting, which are common in a municipality of our size.
